



Cheung Kong Property (Hong Kong): Eligibility in FTSE EPRA/NAREIT Global Real Estate Index Series

Further to the FTSE notice on 29 January 2015 regarding the demerger of Cheung Kong Property from CK Hutchison Holdings (Hong Kong, non-constituent), as the listing of Cheung Kong Property is not an initial public offering but a distribution to existing shareholders, its index eligibility for FTSE EPRA/NAREIT Index Series will be assessed at a subsequent quarterly review following its listing.

Please note the data cut-off date for the FTSE EPRA/NAREIT Global Real Estate Index Series June 2015 is Monday 25th May 2015, and based on the current timetable trading is expected to commence on 3 June 2015, therefore company will be assessed for index eligibility in September 2015 at the earliest.
