



Pandox AB (Sweden): Constituent Addition (Fast Entry) FTSE EPRA/NAREIT Global Real Estate Index Series

Following the listing of Pandox AB (Sweden) on 18 June 2015 and in accordance with FTSE EPRA/NAREIT Global Real Estate Index Series Ground Rule section 7.2.1, FTSE, EPRA and NAREIT announce the following changes.

FTSE, EPRA and NAREIT have reviewed the eligibility of Pandox AB (Sweden, non-REIT, non-Rental) using information in the company's 2014 annual report to clarify certain aspects of the EBITDA breakdown contained in the company's offering prospectus. Based on this public information, Pandox AB meets the required 75% minimum EBITDA threshold for relevant real estate activities for FTSE EPRA/NAREIT Global Real Estate Index Series eligibility.
