- 4. As per company announcement, the relevant CapitaLand Ascott Trust shares will be distributed to the CapitaLand Investment shareholders on or around 12 May 2023. Accordingly, CapitaLand Ascott Trust Temporary Line 1 will remain in the index at market price and will subsequently be removed from the index at market price and the shares will be amalgamated with CapitaLand Ascott Trust (Singapore, BG0RZ29) upon settlement, with T+2 notice. FTSE Russell will issue a further notice in due course.
