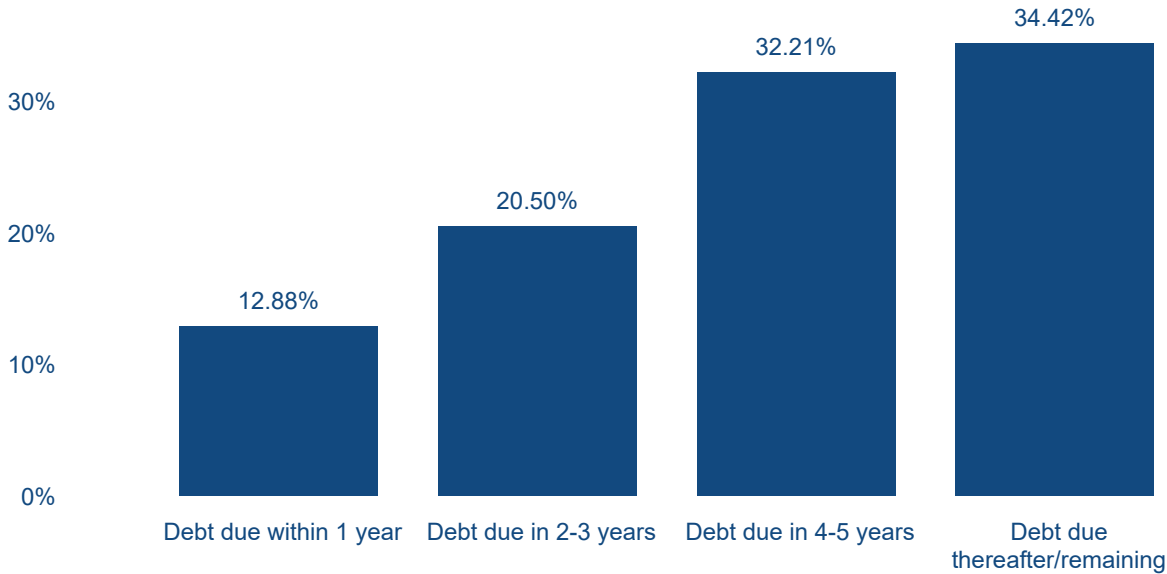

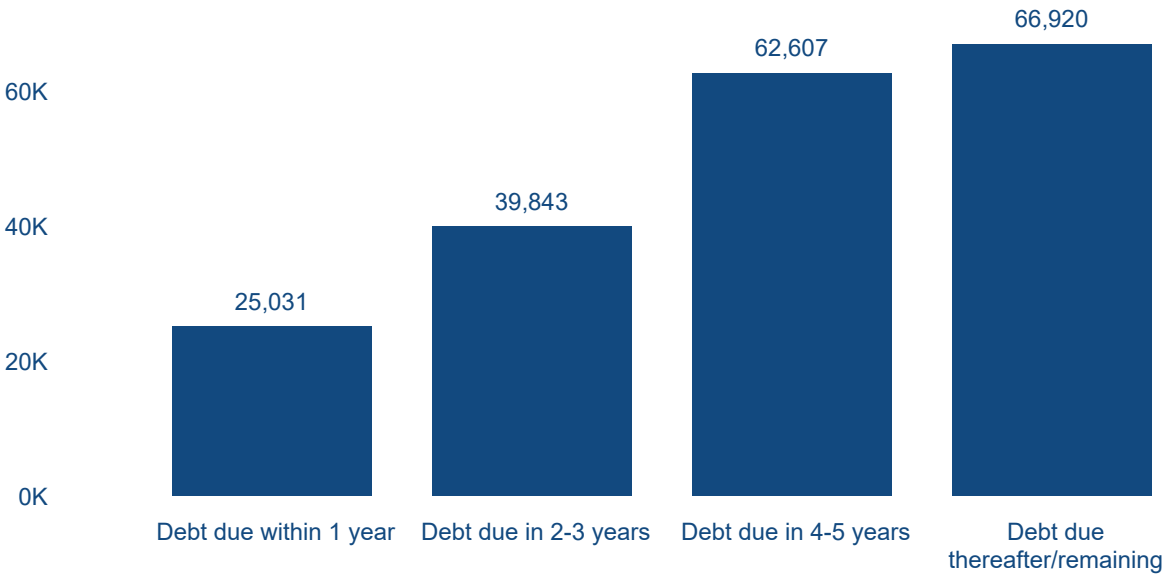

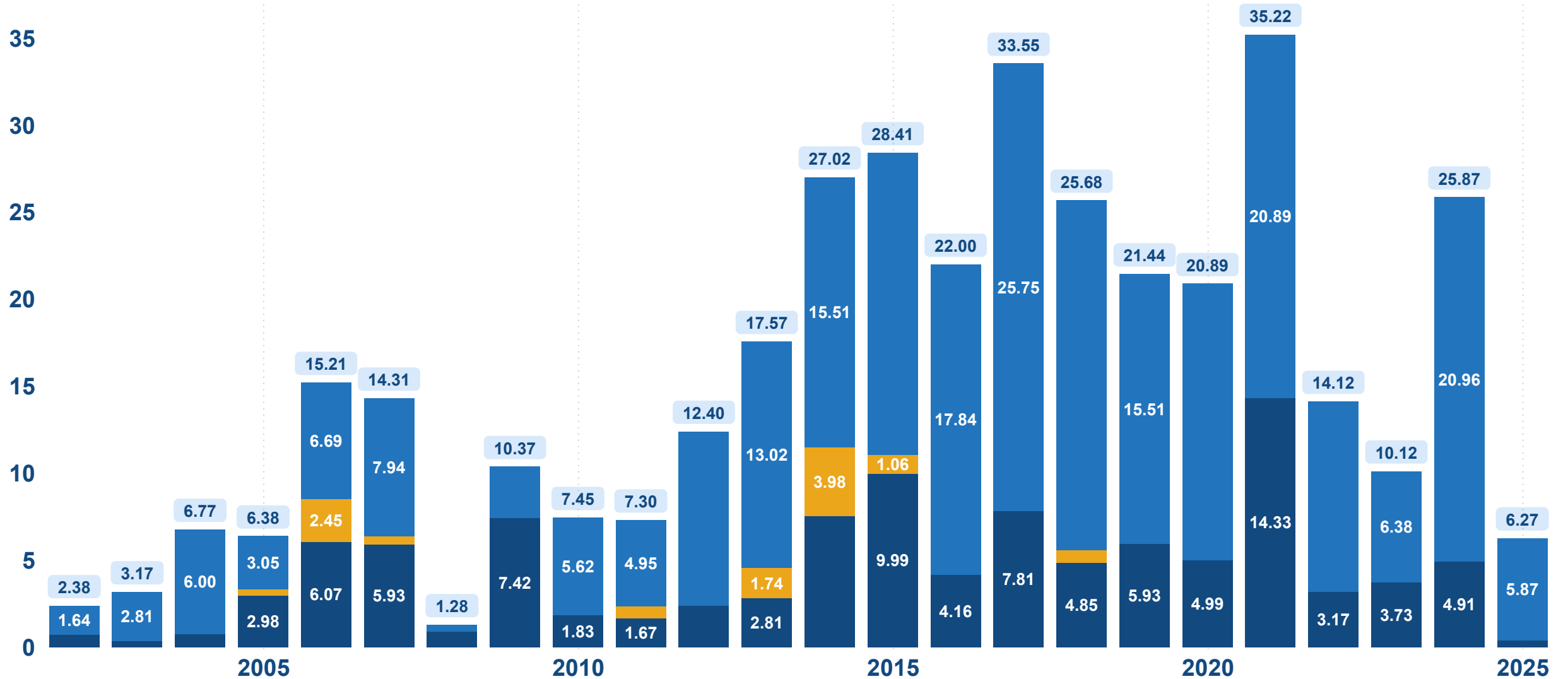

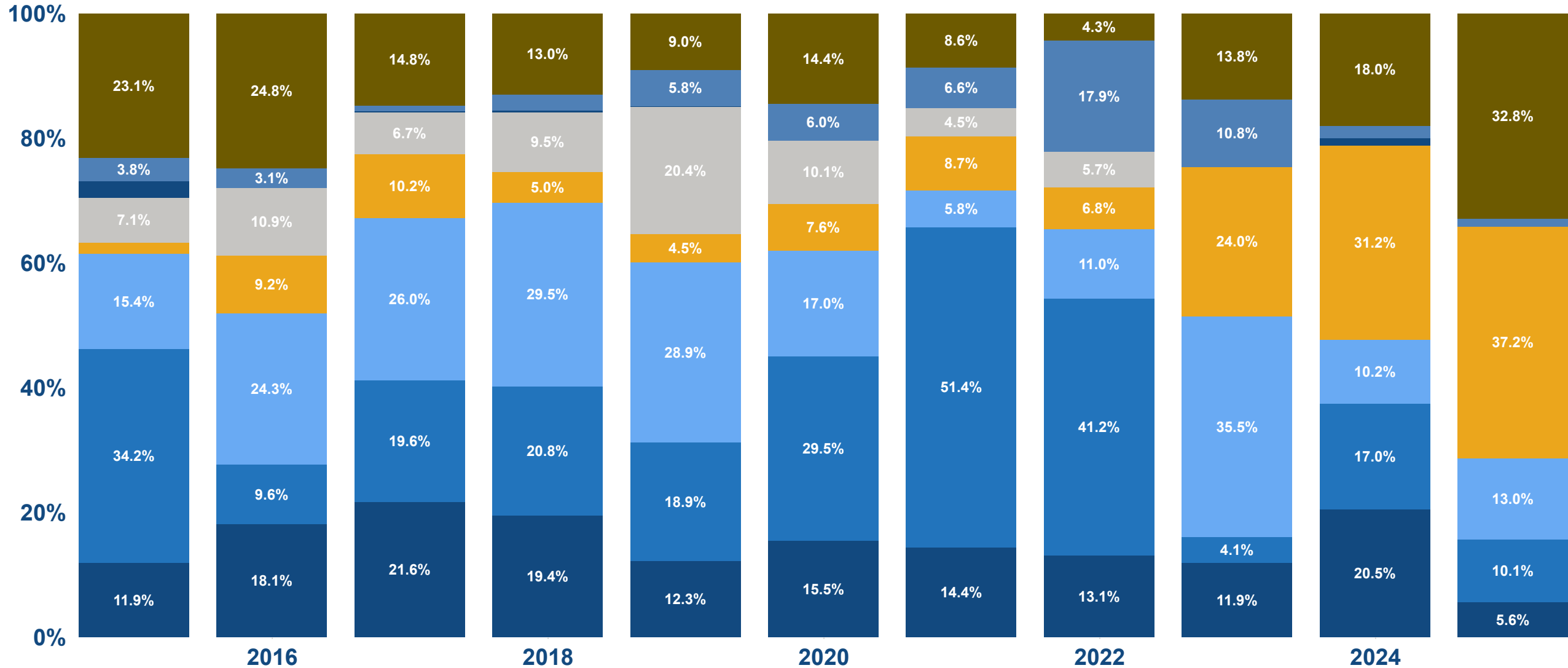

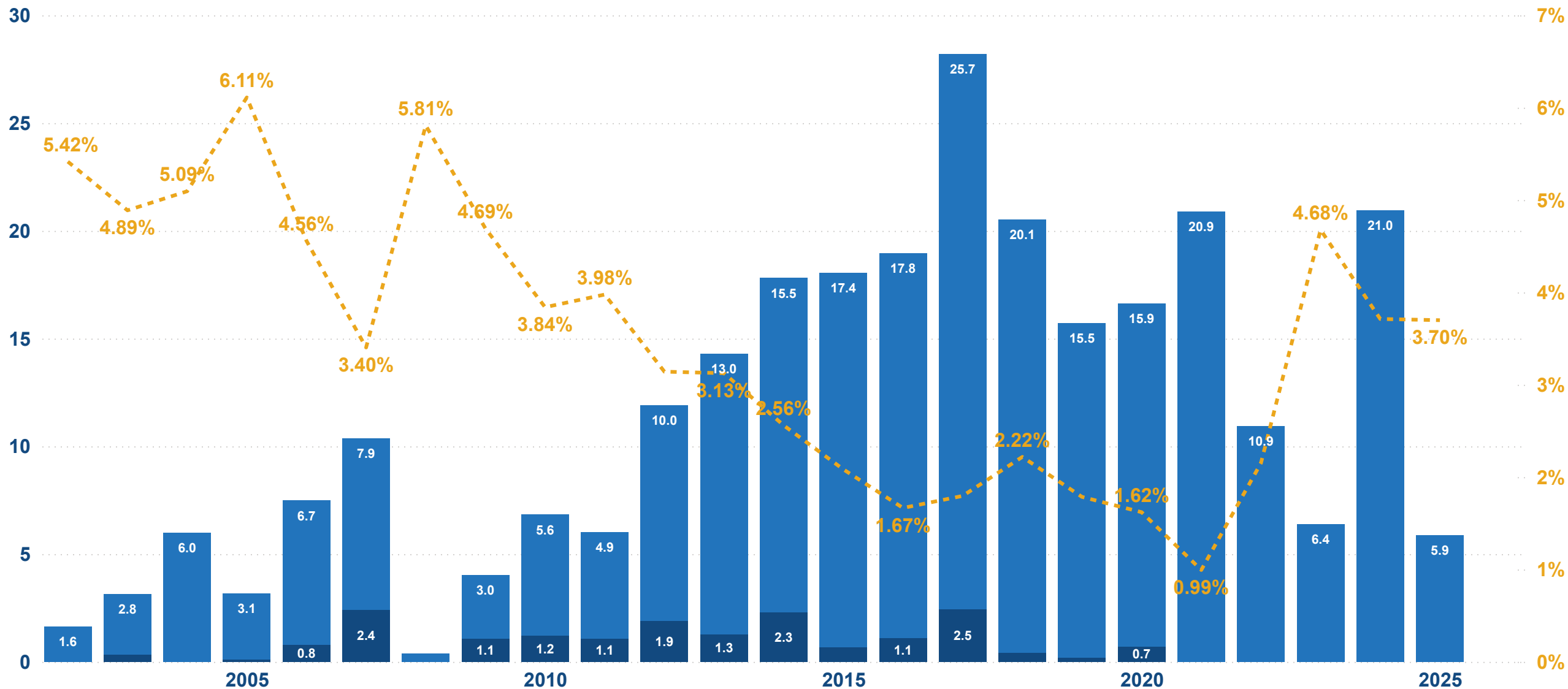

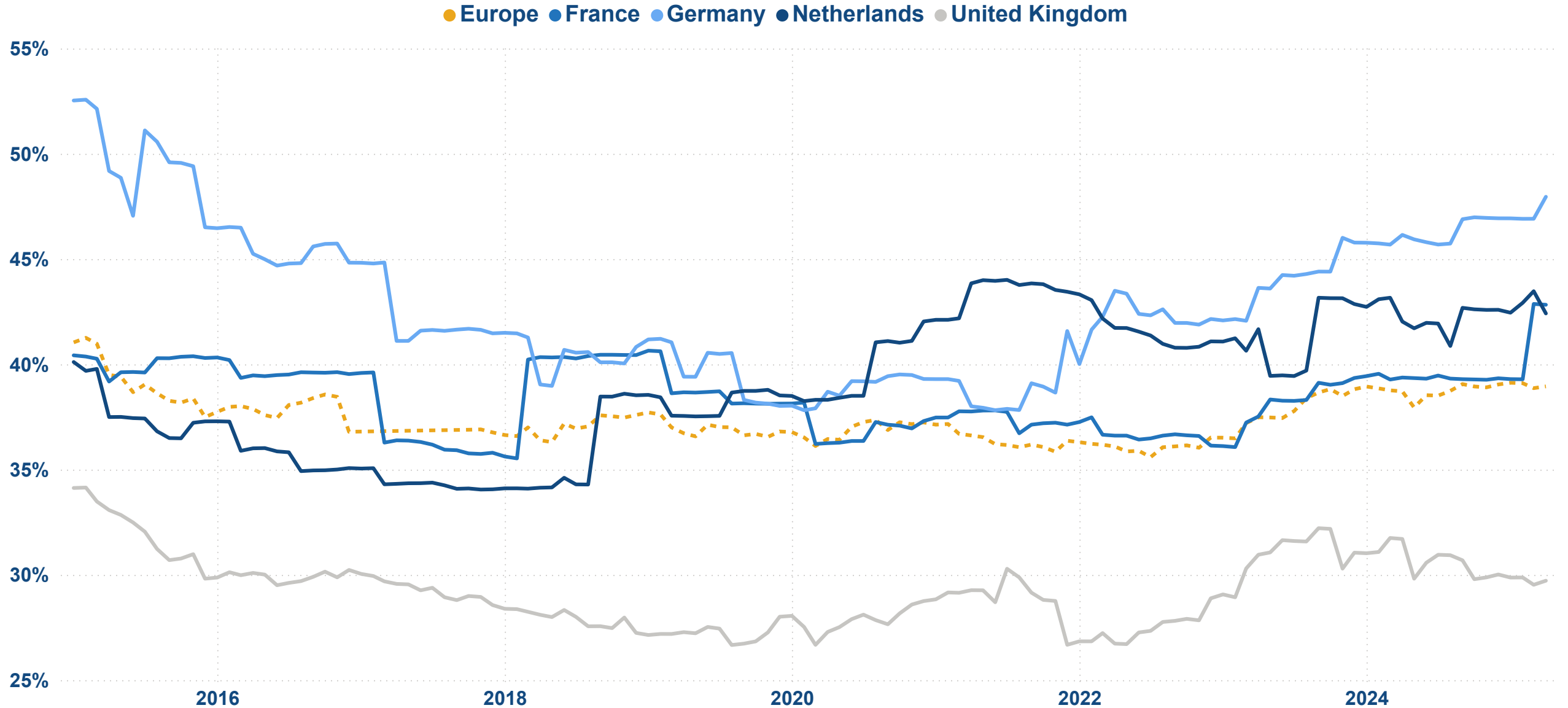

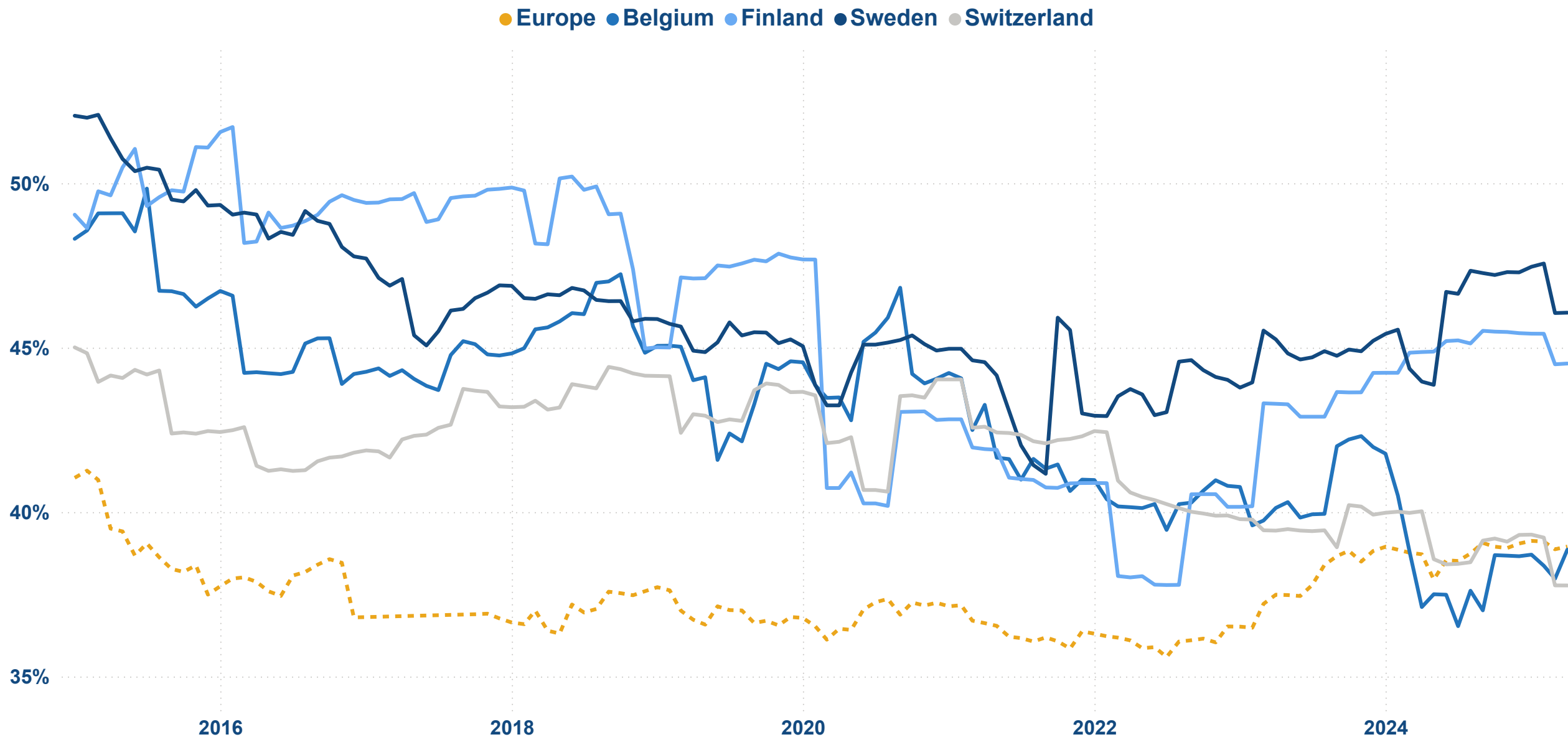


Historical LTV - European Market

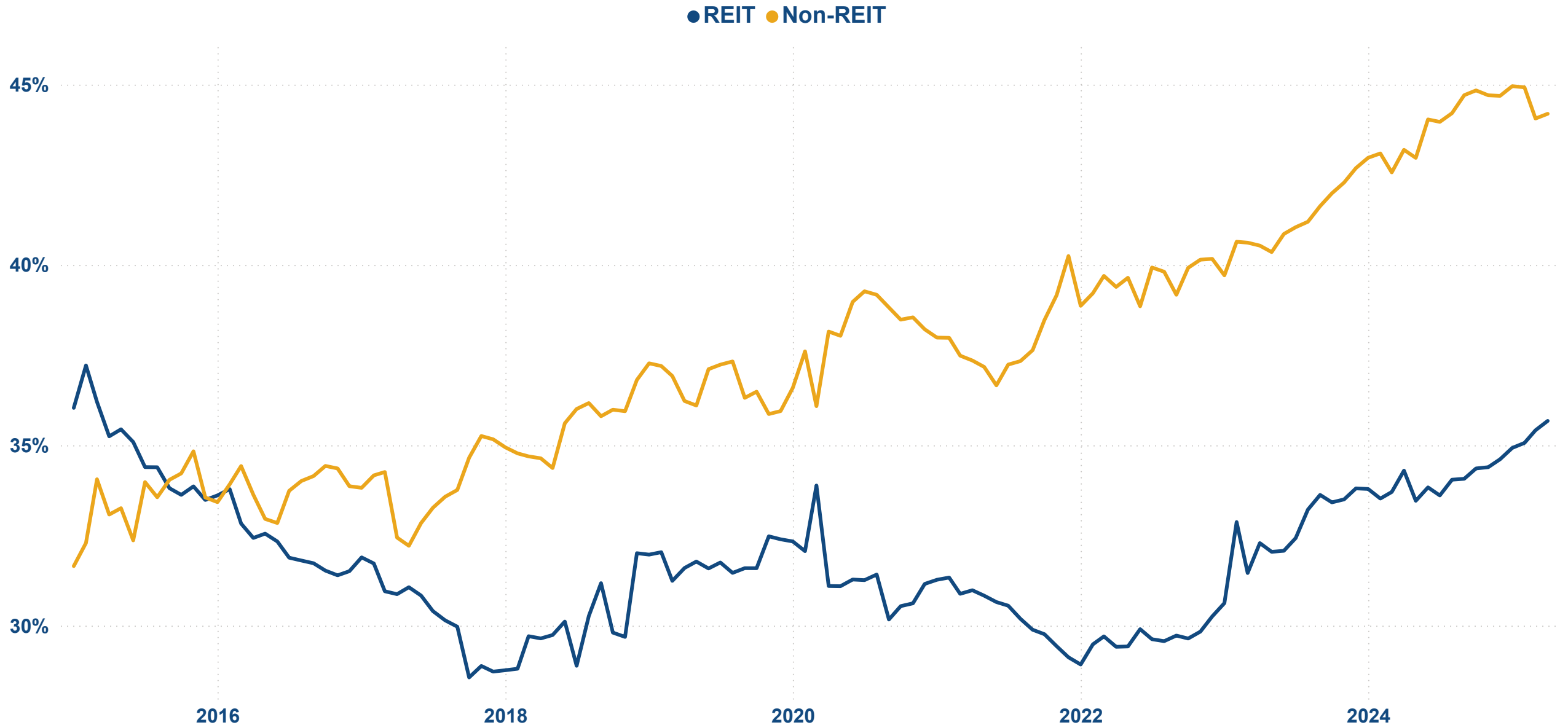

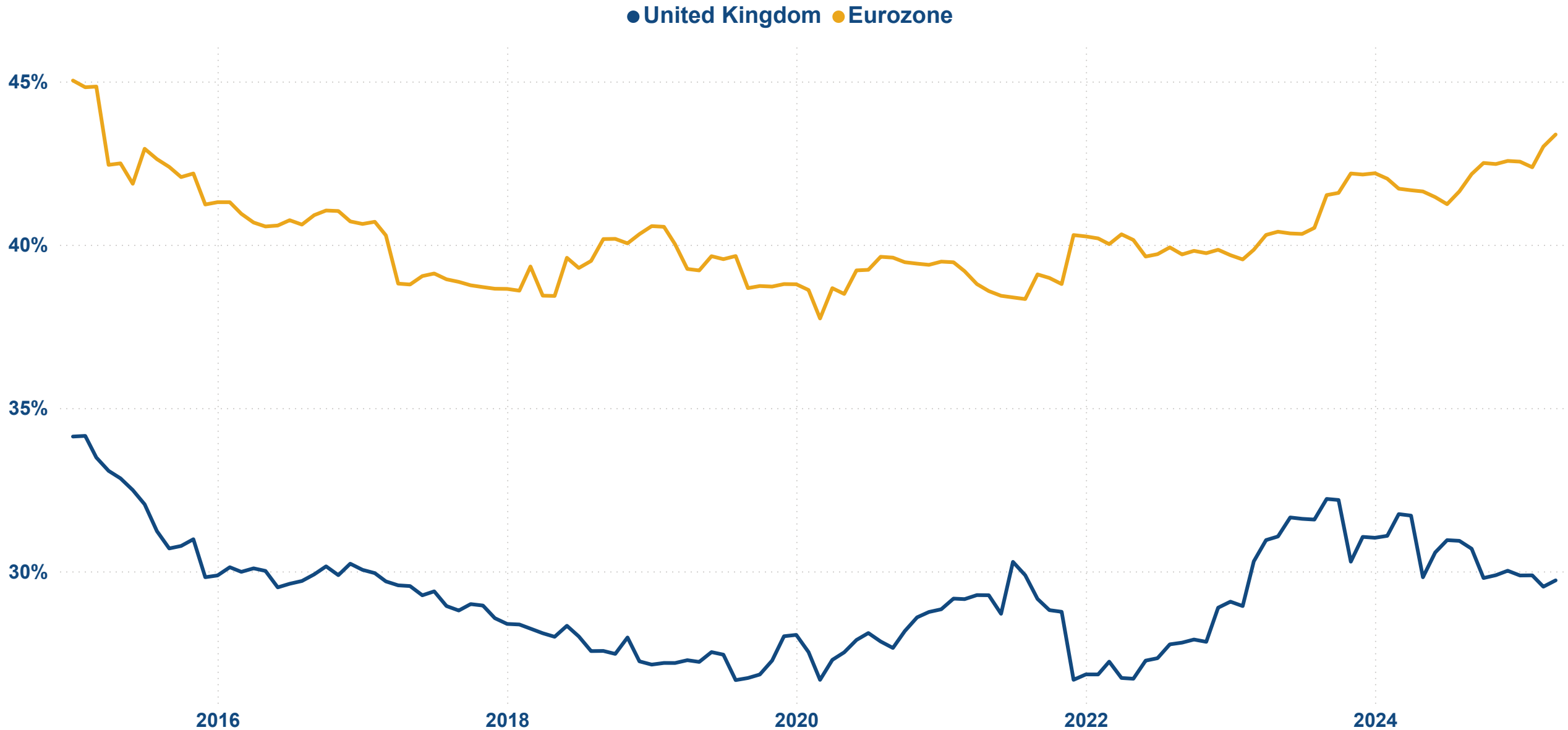


Historical LTV - REIT vs Non-REIT

Historical LTV - UK vs Continental Europe

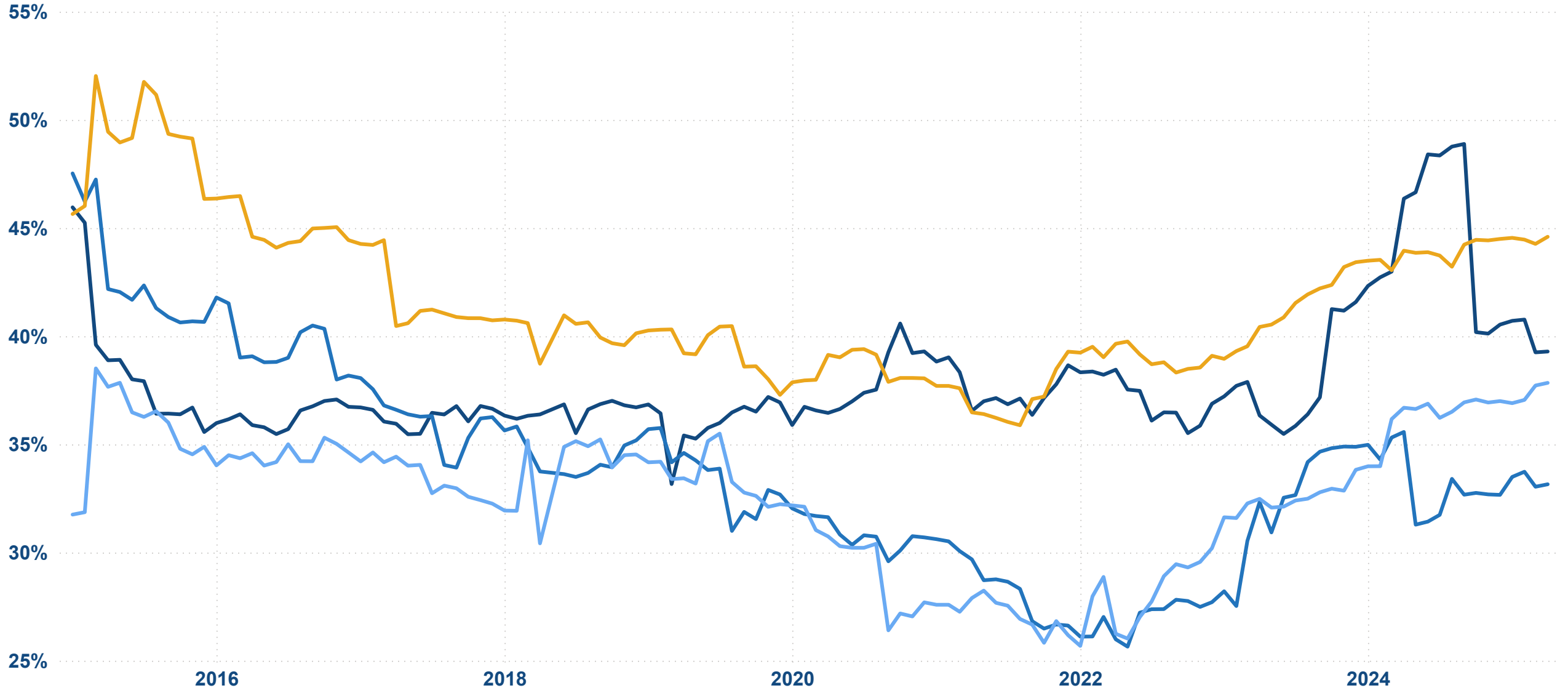

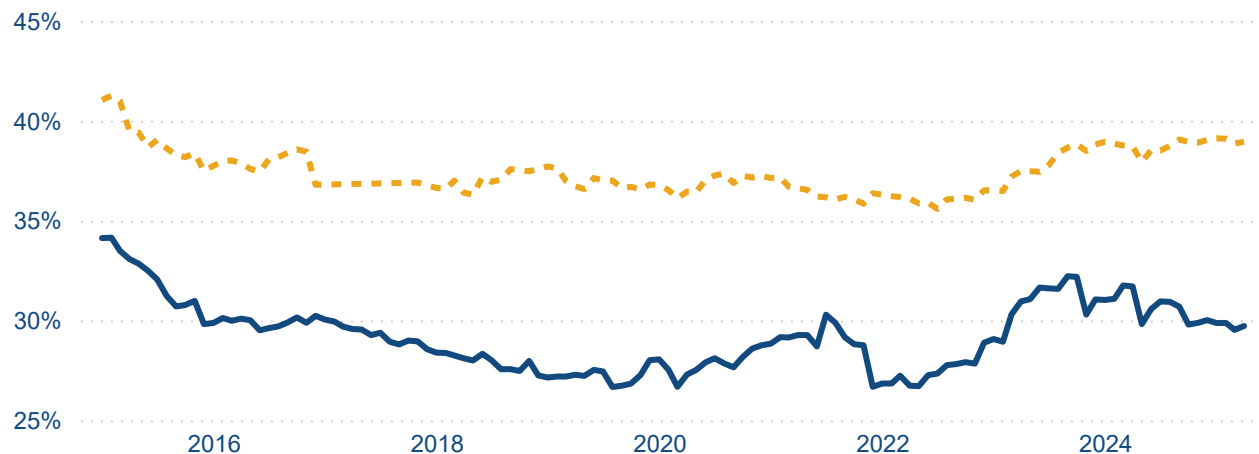

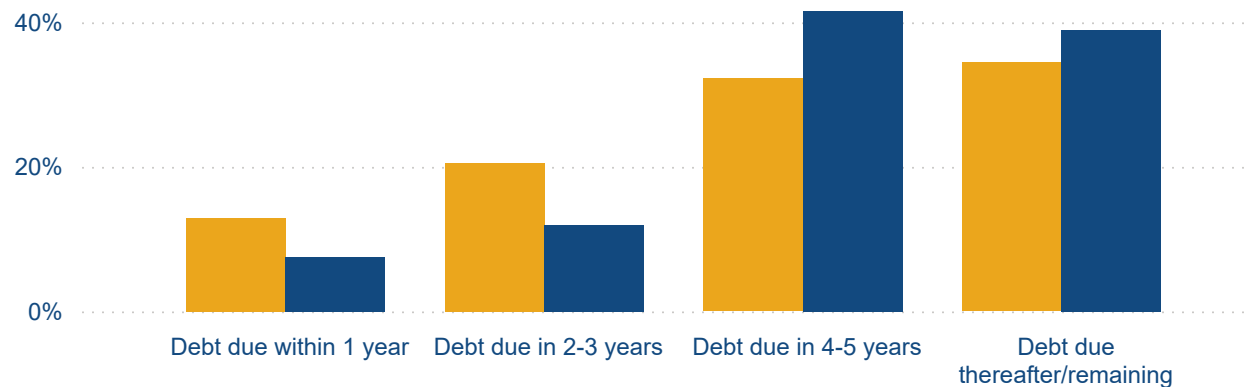

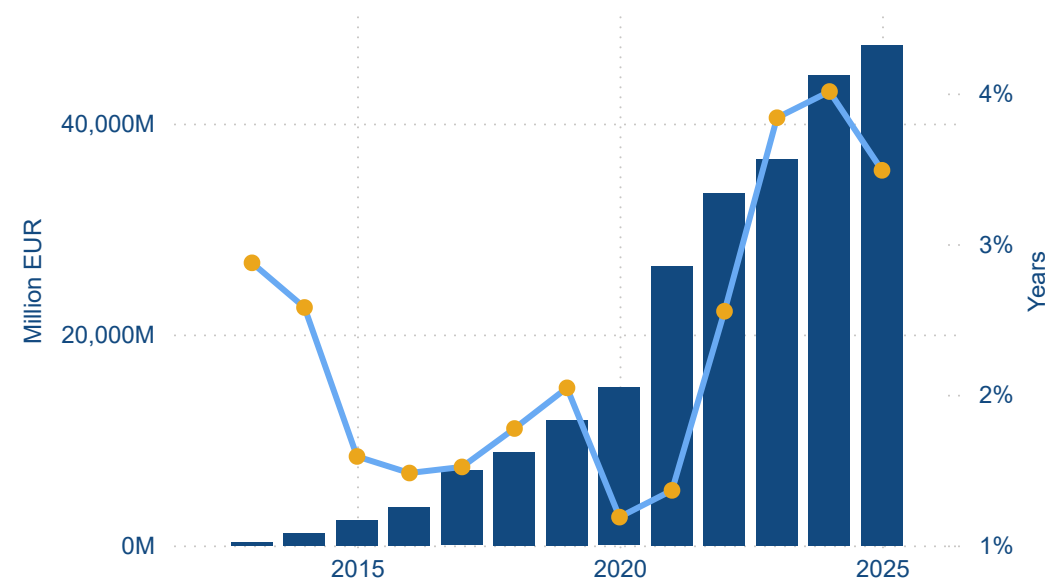
