Notes:	Fonciere Des Regions (France, 7745638) has announced a 1 for 16 rights issue at EUR 65, expected to trade ex-rights on 2 nd March 2015.

As the New shares are not entitled to the EUR 4.3 Dividend to be paid in May 2015, the newly enlarged capitalisation of the company (on a fully paid basis) will be reflected through the inclusion of a line for the rights (based on their market price) and a line for the new shares (on a separate line priced with the subscription price), until they trade on an equivalent basis (pari passu) to the existing ordinary line after the ex date of the dividend (May 2015).

Therefore the market capitalisation of Fonciere Des Regions will be made up of the existing Ordinary Line (7745638), Nil Paid Rights Line (BW39320) and Dummy Call Line (BW4Q3N1). **Effective 23rd March 2015**, the Dummy call and the Nil paid line will be deleted and we will be including the New shares non entitled for dividend on a separate trading line under ISIN Code FR0012476281 until the existing shares start to trade ex-dividend.
